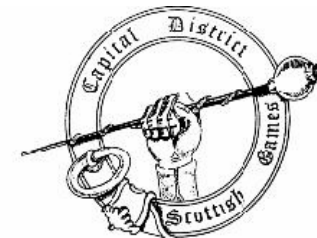

RULES

Entries due (by Postmark) August 7th, 2010.

Competitors 13 & Over will receive a complimentary admission ticket (12 & Under admission is free) with their competitor confirmation letter. If competitor enters **after due date**, they must submit a **\$10 late fee with entry** and risk the chance of not receiving their confirmation letter and complimentary admission ticket.

All must be submitted via postal mail, with payment, prior to the event.

Dancing will conform to SOBHD rules. The decisions of the Adjudicators are final.

Competitors must present their FUSTA/ScotDance card at registration in order to take home awards. Shipment of awards, held due to not presenting registration card, will be at the expense of the dancer's family.

Dancing order will be last to enter, first to compete.

Pre-Premier age groups will be determined by entries.
